EMPLOYEE RESTROOMS

priority of the Executive Director and the Acting State Highway Engineer is the welfare of employees. The Executive Director makes frequent trips to county engineering offices and maintenance complexes. A frequent inquiry she receives regards adequate employee restrooms.

The Director of Maintenance and Capital Improvements Office conducted a survey of restroom needs across the state. It appears that the department

either needs additional restrooms or renovations to current restrooms in about 40 locations.

The offices develhave oped a plan and will begin construction of facilities in the near future.

An option being explored is the purchase of modu-



lar restrooms that are easily expanded should the employee population increase. This type of restroom is used around the country by the National Park Service, and can be constructed faster.

York County Engineering Complex

The 41-year-old York County Maintenance Complex in Rock Hill will be replaced. The new complex will have an administration area housing maintenance and construction engineering staff attached to a Storage Building, a Vehicle Repair Shop/Fuel Facility, and a Salt Storage Building.

Attachment of the administration area to the storage building is a cost savings measure, and affords maximum utilization of the inclement weather/ meeting/training area.

The project was bid on May 4, 2005, with construction slated to begin soon. The new facility should be ready for occupancy in the summer of 2006.

Spartanburg County

Construction of a combination Storage Building/Vehicle Repair Shop/ Fuel Facility and the Salt Storage Building are underway. The new Storage Building/Vehicle Repair Shop/Fuel Facility will be one "U" shaped building thus condensing the land area needed for this complex. Anticipated substantial completion is early September 2005.

District 4 Headquarters

A joint venture between the District 4 Capital Improvements Crew and the Capital Improvements Office is renovating the exterior of the 1954 constructed District Office. The exterior was renovated to match the newly developing surrounding businesses. The exterior is maintenance friendly and pleasing in appearance to the employees and community.

Headquarters relocations

The Claims Office has relocated to Room 207, Safety has moved to 213 and Mass Transit is now located in Suite 201. The Deputy Director for Executive Support and his staff have relocated to Room 342 and Program Control has relocated to Room 345. Final Plans has moved from the fifth floor to G-19, formerly the Safety Office Classroom.

A New Conference and Classrooms have opened on the first floor. The Capital Improvements Office and the Disadvantaged Business Enterprise Office will move in early summer, followed by the Procurement Office. All of these offices will move to the first floor.

Kudos to the primary vendor for the office relocations which is the Department of Corrections, Division of Prison Industries. The Capital Improvements Office is responsible for the development and execution of the five year Comprehensive Permanent Improvement Program (CPIP). This includes Project Management services required in the design and construction of new facilities and major renovations to existing facilities. These facilities include welcome centers and rest areas.



ect Manager with the South Carolina National Guard. He is married to Joan and they have two cats.




Tony Garmon
